



## HINO TRUCKS 'JAPAN 2019' PROMOTION

### 1ST OF JANUARY 2019 TO THE 30TH OF JUNE 2019

#### TERMS AND CONDITIONS:

1. The Promoter is Hino Distributors (NZ) Ltd, 29 Malden Street, Palmerston North, New Zealand.

#### Terms of Promotion

2. Information on how to enter and the prizes form part of these conditions of entry. By entering into the 'Japan 2019' promotion (Promotion) the entrant agrees to be bound by these terms and conditions. Entries must comply with these conditions to be valid.

#### Eligibility

3. Subject to the terms and conditions listed below, a purchaser (Entrant) of any new Hino truck (Qualifying Truck) from the Promoter between 8am Tuesday the 1st of January 2019 and 5pm Sunday the 30th of June 2019 (Qualifying Purchase) will be entitled to a quantity of entries dependant on the Series of Hino truck purchased.
  - i. 300 Series – 1 entry
  - ii. 500 Series – 2 entries
  - iii. 700 Series – 3 entries
  - 3.1 The trip departs Auckland on Sunday 15th of September 2019, returning on Sunday 22nd of September 2019.
  - 3.2 The Qualifying Truck must have been imported by Hino Distributors (NZ) Ltd.
4. To receive an entry into the draw the Entrant must have signed a sales agreement (Qualifying Step) for the purchase of a Qualifying Truck between the 1st of January 2019 and the 30th of June 2019.
5. Hino trucks purchased from the Promoter that are on order and not yet landed are Qualifying Trucks for the purpose of these conditions of entry, provided that the Qualifying Step was completed by 5pm on the 30th of June 2019.
6. The Entrant will not be entitled to enter the draw if, in respect of a Qualified Purchase if:
  - a. the Qualified Step is not completed by 5pm on the 30th of June 2019; or
  - b. the documents necessary to complete the Qualifying Step are incomplete or inaccurate; or
  - c. the Entrant satisfies the Qualified Step but cancels the order prior to the 30th of June 2019.
7. The Promoter will not be liable in any way for the Entrant being ineligible to enter the draw in respect of Qualifying Purchase. Nothing in sections 6 or 7 stop an Entrant from being eligible to enter into the draw with respect to any other Qualifying Purchase that meets these conditions of entry.
8. Employees and their immediate families of the Promoter are ineligible to enter.
9. No Promotion entry is redeemable for cash or transferable to another person.

### Prize details

10. The Prize includes – return flights to Japan, transfers and 6 nights' accommodation in Japan, English speaking guides, tickets to the opening ceremony, official match tickets to Japan vs Russia and New Zealand vs South Africa, a tour of Hino factory, Japan sightseeing experiences, breakfast and some lunch and dinners.
11. Excluded from the prize and as the sole responsibility of the Winners are: domestic flights and accommodation prior to and post Japan trip, travel insurance, room service and minibar expenses, laundry, bank charges for currency exchange, costs associated with non-scheduled activities and non-refundable changes to the scheduled itinerary. 13. A total of 8 qualifying customers will be drawn. Where a customer's name is drawn more than once another draw will take place immediately. Where a customer is found to not meet the terms of the Competition another draw will be made as soon as possible.
14. Each eligible customer drawn will receive 1 Prize. Each prize will allow for one person to travel.
15. A Prize will be awarded to the customer to whom the vehicle is registered to and cannot be gifted to another person not associated directly with that customer/company i.e. a person who is not an employee, owner and shareholder.
16. Upgrades to the specification of a Prize will be solely at the Winner's cost.
17. The Promoter reserves the right to validate and check the authenticity of any prize claim or entry before awarding a Prize.
18. The Promoter may, at its sole discretion, disqualify all entries from, and prohibit further participation in the Promotion by and person who tampers with or benefits from any tampering with the entry process or with the operation of the Promotion or acts in violation of these conditions of entry.

21. If the Winner attends the trip and cancels the order for the Qualified Truck or if the Winner has not paid for the Qualified Truck by the 30th of June 2020 the Winner agrees to reimburse the Promoter the cost of the Prize.

Where a Prize is unavailable for any reason, the Promoter may substitute for the Prize another item of equal or higher value as determined by the Promoter.
